#### **DORMANT ACCOUNT NOTICE**

Member accounts without activity (other than earning dividends) are considered dormant after one year. Once an account is dormant, a special warning is placed on the account and a dormant fee is charged each month until the account is reactivated or closed due to a \$0.00 balance. HarborLight CU sends a pre-dormant notification letter when you have had no activity for 11 months to encourage you to activate your account and avoid this fee. Therefore, it is important to update your contact information with us whenever there is a change. After three years of inactivity, HarborLight CU is required by state law to turn the funds over to the Division of Unclaimed Property of the state of the last known address. Obtaining funds from the state can be an involved process, which can be avoided if you perform at least one transaction per year. Be sure to review your statements to verify when the last transaction was made and that all transactions were authorized. For more information, give us a call at 231.894.5608.t
